Kerala Industrial Infrastructure Development Corporation (KINFRA) invites sealed, super-scribed tenders as prescribed from technically and financially competent 'A' Grade Electrical Contractors with valid license for the following work in two bid system.

Eligibility criteria:

1. The Tenderer should have valid 'A' grade Contractor's license from Kerala Electrical Inspectorate. Tenderer should have successfully completed at least one HT work involving supply and installation of transformers/ HT panels/HT cables of value not less than 80% of PAC (Rs 86.4 Lakhs) in a single work during any one of the last three years as prime contractor for reputed public or private organization. Copies of the work orders and completion certificate to be furnished to support this.
2. Annual turnover should be more than 150 % of PAC (Rs 162 Lakhs) during the last three financial years.
3. Tenderer should have adequate equipment and staff to undertake quality control activities, proper monitoring of the execution and achieving targets and mile stones as per the accepted time schedule. Joint ventures and consortiums formed for the purpose of bidding are not eligible to quote the tender.

4. Tenderer should produce solvency certificate from any nationalized Bank or scheduled Bank to an amount equivalent to 40% of PAC. (Rs 43.2 Lakhs)

The tender documents (non-transferable) can be obtained from the park centre **KINFRA Small Industries Park, Nellad** on cash payment of Rs 10800.00 + VAT (Rupees Ten Thousand Eight hundred only + VAT only) or as Demand Draft payable at Thiruvananthapuram and drawn in favour of Kerala Industrial Infrastructure Development Corporation, during office hours on any working days from June 24th to July 7th.
